If you heard the crumpling of paper about a week ago, that was me tossing away my other newsletter article that I previously wrote. I was moved to write on something totally different than my original theme. So, here goes...

Over the last year, my priorities has been to assess our readiness to receive a new pastor. That has included education, a walk down

His father came out and entreated him, ²⁹ but he answered his father, 'Look, these many years I have served you, and I never disobeyed your command, yet you never gave me a young goat, that I might celebrate with my friends. ³⁰ But when this son of yours came, who has devoured your property with prostitutes, you killed the fattened calf for him!' ³¹ And he said to him, 'Son, you are always with me, and all that is mine is yours. ³² It was fitting to celebrate and be glad, for this your brother was dead, and is alive; he was lost, and is found."



ARTIFICIAL INTELLIGENCE

We are seeing all the many ways in which artificial intelligence (AI) affects our lives, impacting our computers, cell phones and



Scammers are recording individuals voices from various sources and using Al-cloned audio, putting together complete conversations using



the persons voice patterns. The conversation sounds so realistic that a person receiving a phone call cannot tell it is not the person they know. Now add an urgent plea for help or the person is in jail or injured and the person called goes into panic mode, agreeing to the instructions providing the caller money to resolve the situation.

A woman in Florida lost over \$15,000.00 because of scammers using Al to mimic her daughters voice saying she was in a fake vehicle accident. Her daughter was at work the entire time. Scammers can provide telephone numbers that are similar to or are an actual number you may be familiar with. For your safety, provide a code word that only your family will know to prevent you from being taken advantage of.

GO FUND ME

Recent reports indicate that scammers are hijacking various funds from the fund-raising site GoFundMe. The site has experienced this in the past. Be sure any charity you are donating to will actually deliver the funds to the intended recipients.

Minutes of Council Meeting – June 17, 2025 / 4:00 PM

Opening:

The regular monthly meeting of the council was called to order on June 17, 2025 at 4:00 PM by Jim Sommers, President. Pastor Kohls led us in the opening prayer.

Secretary Report:

Garry Preder made a motion to approve the May 13, 2025 Secretary's Report, Penny Geiger seconded the motion, motion carried.

Treasurer Report:

Beginning balance May 1, 2025 - \$5008.78 - Ending balance May 30, 2025 - \$2965.91. Profit from May brat fry was \$1377.63. Lynn Kind made a motion to approve the Treasurers report, Penny Geiger seconded the motion, motion carried.

Committee Reports:

Pastor's Report: Report was reviewed and discussed with Council.

Buildings and Grounds: Derek replaced the switch and circuit breakers for the outdoor automatic entrance.

Derek Beyer made a motion to accept the committee reports as submitted,

Garry Preder seconded the motion, motion carried.

Old Business:

- Congregational meeting feedback no comments from congregation
- Liaison committee updates Jim Sommers contacted several individuals to join the Outreach Committee
- Sign upgrade status Derek Beyer will contact Kelly Sippel and Mike Kovach regarding replacement of the sign. He will also get measurements and contact several sign companies for options and pricing.

Garry Preder made a motion to utilize conference resources to help us assess time, talents and other resources available to the Church from congregation, Penny Geiger seconded, motion carried.

New Business:

- Review Sunday worship service start time Proposing starting at 10:30 to show goodwill to Ebenezer and help them have some time with Pastor Kohl's after service. Will need to be discussed with the congregation.
- Security update, monitoring, proactive planning Jim Sommers proposed pricing out cameras to be located in various areas of the church as well as installing keyless entry to all exterior doors and rekeying the main entry door. Garry Preder made a motion for Jim Sommers to install keyless entry on all exterior doors, rekey main door and get pricing on cameras for security, Derek Beyer seconded, motion carried.
- Review and discuss audio/visual proposal offered by Scott Wink Scott Wink is offering to lead a project to update our audio and cameras as well as add some large screen tv's. Lynn made a motion for Jim Sommers to further discuss and investigate this project with Scott Wink, Garry Preder seconded, motion carried.
- Set date and time for council to meet with Search committee Jim Sommers to contact Jill Sippel to set up the meeting for July 15, 2025 at 5:00pm. Derek Beyer made a motion for Jim Sommers to contact Rev. Jane Anderson regarding our position on the church profile, Garry Preder seconded, motion carried.
- Derek Beyer received a call from a Council member of St. Paul Church in Malone regarding the Iverson scholarship. Council would like to reanalyze the scholarships and speak with the family regarding 4-year college vs. tech school eligibility.
- Pastor Kohls was excused from the meeting to allow the council to review and discuss the Designated Term Ministry Covenant agreement between Pastor Kohls and St. John United Church of Christ. After discussion, it was unanimously agreed to honor the direction given by the congregation and enter into the covenant with Pastor Kohls. The agreement has been signed and is binding for the period July 1, 2025 through the end of calendar year 2025.


