Psssttt... Have you heard? No? Really?! Let me elaborate...

The number of available pastors for churches is pretty low right now. Currently, for every available pastor, there is between two and three open pulpits throughout the United States. And... this is not just an issue for the United Church of Christ, but for almost all faith

traditions; UCC, Lutheran, Catholic, Presbyterian, Methodist, and the list goes on. As disconcerting as it is not to have enough congregational members helping to do the work of the church, within the local churches, the problem becomes escalated when people refuse to consider a call to ministry.

Recently I've been asking people why they are not considering a call to ministry. Here are some of the answers shared with me:

I'm too old / I'm too young
I don't like sitting in a classroom, having to learn new stuff
Pastors don't make enough money
I'm not smart enough
Too much writing
I've never gone to college
I'm afraid of giving the wrong advice
I'm afraid of failing and letting a congregation down
It doesn't seem like I have any way of advancing my career
I don't like speaking in front of large groups
I have blemishes in my past

While not every person is called to the ordained ministry, many of us are called to service within the church in varying forms. For some, a call to 'the church' could look like a series of very small steps. For others, a call to ministry can be a dramatic and earth-shaking feeling. God speaks to us, God calls each of us in a multitude of varieties or ways. Consider what Jesus shares in Revelation 3:20, "Look! I have been standing at the door, and I am constantly knocking. If anyone hears me calling him and opens the door, I will come in and fellowship with him and he with me." There is a door between us and God. Is anyone willing to open the door and let Jesus in?

Going back to the list of 'excuses' mentioned above. While each of them is worthy of conversation, rarely will any one of those be a 'STOP' button for moving forward for a call in serving 'the church'. There are many ways of gaining education, insight, and wisdom regarding ministry and ministry opportunities. The one-size-fits-all approach to ministry is a thing of the past.

If you have any sort of nudge, spiritual question, holy calling, or even a harmless inquiry about ministry, about life in 'the church,' let's talk. There's a seat waiting for you.

WEATHER NOTIFICATIONS

As we enter the winter season, we receive information regarding weather conditions from various news sources as well as the National Weather Service. What do the various weather alerts mean and how are they determined?



A Winter Storm Warning is issued that heavy snow of at least 6 inches in 12 hours, or at least 8 inches in 24 hours is expected. It can also be issued if sleet accumulation will be at least a half an inch.

An Ice Storm Warning indicates ice accumulation of least a quarter inch is expected.

A Blizzard Warning indicates that blizzard conditions (low visibility of less than a quarter mile due to falling and blowing snow, and winds at least 35 mph. or higher gusts) are expected for at least 3 hours. The warning is issued when conditions are expected in the next 12 to 18 hours.

A Winter Weather Advisory is issued for snow 3 to 5 inches in 12 hours or sleet accumulation up to a quarter inch or freezing rain in combination with sleet and or snow or blowing snow.

A Freezing Rain Advisory indicates that ice accumulation of up to a quarter inch is expected.

The criteria used by the National Weather Service for each of these advisories and warnings are quite extensive. The information provided is a brief overview.

During periods of extreme weather if travel conditions are hazardous, St. John UCC will provide closing information on WBAY television Green Bay.

ONLINE SHOPPING

Seasonal deals have started to appear on many websites. Consider whether the shopping sites you are using are legitimate sites. Fraudster's in some cases have set up webpages to look like the real site. Once they have your money or personal information, they close the site just as fast as they open it.

Minutes of Council Meeting – October 21, 2025 / 4:30 PM

Opening:

The regular monthly meeting of the council was called to order on October 21, 2025 at 4:30 PM by Jim Sommers, President. Pastor Kohls led us in the opening prayer.

Attendees List:

Approval of Agenda:

Garry Preder made a motion to approve the agenda, Penny Gieger seconded the motion, motion carried.

Secretary Report:

Derek Beyer made a motion to approve the September 16, 2025 Secretary's Report, Garry Preder seconded the motion, motion carried.

Treasurer Report:

Beginning balance September 1, 2025 - \$7,773.37 - Ending balance September 30, 2025 - \$4,217.56. Lynn Kind made a motion to approve the July 2025 Financial Statement as submitted, Penny Gieger seconded the motion, motion carried.

Pastor's Report: Report reviewed and discussed with Council.

Committee Reports:

Buildings and Ground:

- Broken masonry below drop box was repaired by Derek's father-in-law for a cost of \$100.
- Mannenbach Heating has our boilers scheduled to be serviced.
 Garry Preder made a motion to accept the committee reports as submitted, Derek
 Beyer seconded the motion, motion carried.

Old Business:

- Appleton sign company has given an estimate of approximately \$30,000 to replace the sign. Possible fundraiser in the future to help offset the cost.
- Brat fry will be October 26, 2025 Derek Beyer to check with Donna Schneider to verify the Fire Station sign will advertise for that day. Yard signs out.
- 4 volunteers have reached out to help Michelle and Jena with Sunday School when needed and have been cleared.
- Rev. Andrew Werner to meet with the council on October 28, 2025 for a financial education meeting.
- Jim Sommers sent an email to thank the Cooley family for the generous donation of the artwork that is now on display in the lounge.
- Nancy Beckman from St. Martins, Malone, reached out to Derek Beyer informing him that their council reached out to families in their parish to make changes to the scholarship funds and will email us how they are proceeding.

New Business:

- Council would like to establish a greeting card program for members of the church who have had a significant event to include the death of a family member, wedding or birth. Lynn Kind made a motion to approve a greeting card program for church members, Garry Preder seconded the motion, motion carried.
- Jim Sommers gave an update on the current insurance situation. Current insurance underwriter Hub International Limited has advised they will no longer be representing our current insurance coverage provided by Hastings Mutual Insurance. Jim is currently working to obtain insurance quotes from other agencies. Current coverage expires 2/1/2026.

Derek Beyer made a motion for Council to go into executive session at 5:07pm, Penny Geiger seconded, motion carried. Garry Preder made a motion to return to regular session at 5:56 pm, Lynn Kind seconded, motion carried.
