

2024 WISCONSIN STATEWIDE TORNADO DRILL

As we enter spring and summer this is the most active time of the year for tornadoes, however they can occur at anytime throughout the year. Wisconsin averages twenty-three tornadoes per year according to the National Weather Service.

THURSDAY, APRIL 11, 2024, TORNADO DRILL 1:45 P.M. & 6:45 P.M.

During the drill Wisconsin National Weather Service offices will conduct tests of NOAA weather radios. If you have one of the weather radios programmed to activate test alerts, you will hear the alert information. During the test period communities may test their outdoor warning sirens. Local radio and television stations may also provide a test alert message and you may also see social media posts. In the event of severe weather in Wisconsin the test will be rescheduled until Friday, April 12, if severe weather is expected on Friday the drill will be cancelled. There will not be any wireless emergency alerts, push notifications on phones or test watch/warning during the drill.

IMPORTANT TERMS

TORNADO WATCH — means conditions are right for a tornado to develop. Continue with normal activities but continue to monitor the situation.

TORNADO WARNING – means radar or weather spotters have identified a tornado. The emergency sirens will sound a steady tone for three minutes or longer if there is danger in the immediate area.

In the event of a tornado warning, seek immediate shelter preferably in a basement or below ground evacuation location. A steel-framed or reinforced concrete building will provide some protection. In a multistory building find shelter in an interior hallway or the lowest floor. Basements and interior hallways, and bathrooms on lower floors provide good shelter. If you find yourself surrounded by debris, be extremely careful in attempting to remove any of the material as there may be a danger of building collapse. If it is not safe or possible to leave the area remain there until help arrives.

This is the perfect time to practice your emergency plan to protect yourself and family members. Know where to go and have a "Go Bag" ready with those important items that you might not be able to replace. Being proactive in advance of an emergency is extremely important.

Stay safe, and remember if you see something, say something.

Institute of Paper Company and was responsible for the paper whiteness for mills across the US and abroad.
